The Diamond plan offers face to face classes for the real classroom experience as well as the option of online classes along with fast track classes.

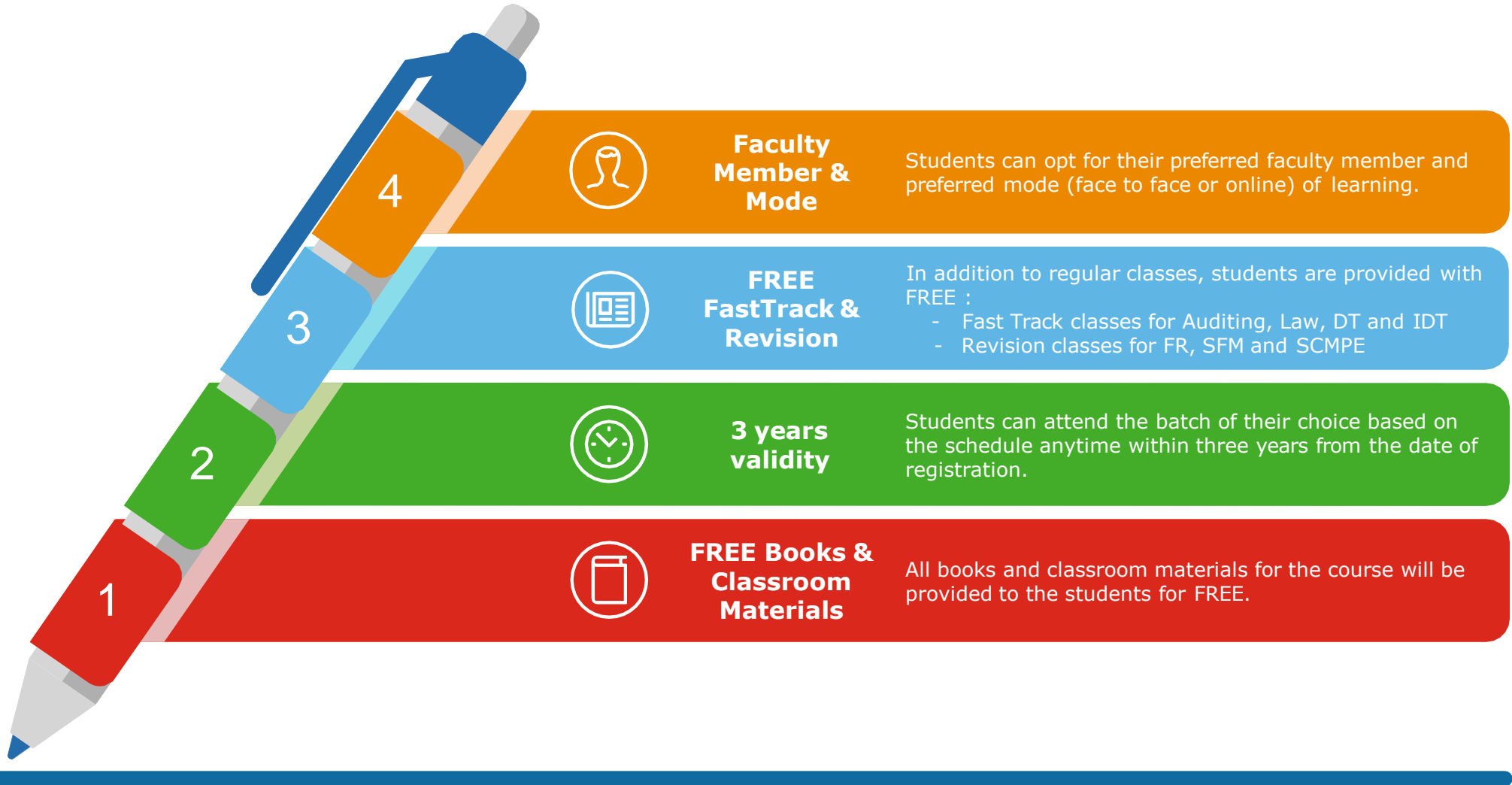

5. Duration mentioned above is based on F2F classes. For online mode, number of hours have been mentioned in page 9,10 and 11.

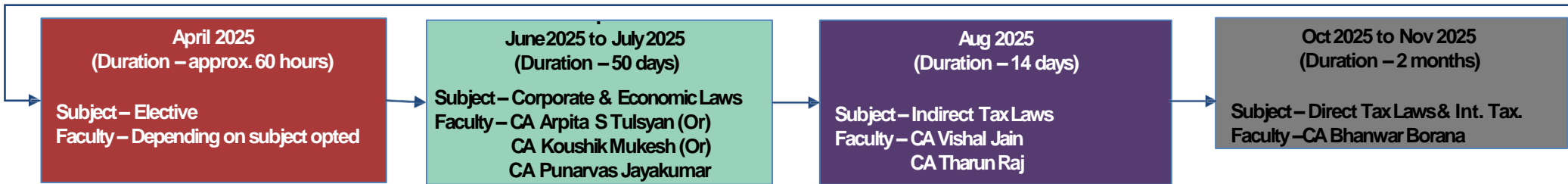
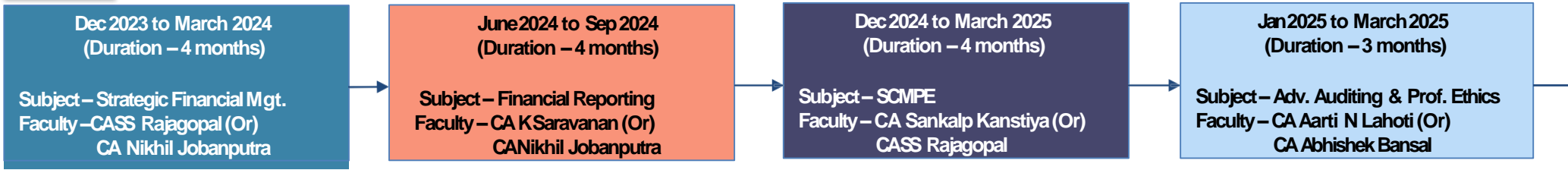
